SEASONAL FIREFIGHTER

DESCRIPTION

Under general supervision, participates in emergency fire suppression, emergency medical care, fire prevention and investigation activities, and other activities that support the protection of life and property; assists in the maintenance and care of all stations, apparatus and equipment; participates in training exercises and study of firefighting techniques; learns to maintain apparatus and equipment in a state of readiness; participates in public education programs related to fire prevention and safety; participates in out-of-county fire and rescue assignments; maintains hydrants and hoses; demonstrates a full understanding of all applicable policies, procedures and work methods associated with assigned duties; performs related duties as assigned.

SUPERVISION RECEIVED AND EXERCISED

Receives general supervision from a Fire Captain. Does not routinely exercise supervision.

TYPICAL DUTIES AND RESPONSIBILITIES

- Responds to fire, rescue, medical, hazardous materials and other emergency alarms by driving and operating fire
 apparatus, other emergency vehicles and equipment when qualified; may select the most direct route of
 response.
- Operates a variety of hand and power tools such as rescue saws and harnesses, extrication tools, chainsaws, dry
 chemical extinguishers, pike poles, extension ladders, pickhead axes and other related tools; assumes primary
 responsibility for the inspection, servicing and maintenance of assigned vehicles, equipment and tools to ensure
 readiness in emergency situations.
- Perform a variety of fireground and emergency scene tasks.
- Demonstrates a full understanding of applicable policies, procedures, work methods and safety requirements associated with assigned duties.
- Performs or assists in the suppression of fires and protection of life and property; administers emergency
 medical aid; inspects commercial and residential structures to insure compliance with federal, state and local
 fire prevention laws, codes and regulations; participates in training for emergency situations.
- Assists in the maintenance of fire station, quarters and surrounding grounds.
- Assists with rental and maintenance of District's community hall.
- May respond to State and National Incidents under State Master Mutual Aid (Strike Teams) or FEMA requests in any position qualified.
- Responds to questions and concerns from the general public, provides information as is appropriate and
 resolves complaints; participates in public education programs related to fire prevention and safety; conducts
 station tours.
- Build and maintain positive working relationships with co-workers, other District employees and the public using principles of good customer service.
- Promote and maintain safety in the work place.
- Perform collateral assignments as requested.

DISTINGUISHING CHARACTERISTICS

The Seasonal Firefighter is the apprentice level class responsible for learning the full scope of assigned duties including fire suppression, prevention, emergency medical care, inspecting and maintaining fire apparatus and equipment.

WORKING CONDITIONS/ASSIGNMENTS/PHYSICAL DEMANDS

- Work is conducted both in a fire station and in the field in various settings.
- Some of these include exposure to smoke, odors, heat, steam, fumes, and dust; as well as periodic exposure to dangerous or life threatening situations.
- Performs tasks requiring: strength and stamina, such as lifting and moving equipment and objects weighing up
 to 100 pounds; pushing or pulling objects of up to 100 pounds; sitting, standing, walking on uneven or slippery
 surfaces, kneeling, bending, twisting, turning, stooping, squatting, grasping and crawling; ascending and
 descending stairs and ladders; work both inside and outside with exposure to extreme weather conditions,
 odors, dust and pollen; exposure to chemicals, skin irritants, fumes and solvents; frequent hand and arm
 motion
- Must have: hand and finger dexterity sufficient to use small tools; the ability to see well enough to read gauges, documents and street maps; accurate depth perception; the ability to communicate verbally, including projecting a voice that can be heard in a noisy environment; the ability to hear and distinguish various sounds, such as alarms, voices of co-workers and warning horns or sirens in both quiet and noisy environments; the ability to stand, walk, bend and reach at, above or below shoulder height for extended periods of time; sustained concentration and prolonged commitment to job tasks; interpersonal skills sufficient to work closely with others on a team; high level cognitive, interpretive or judgment skills; ability to demonstrate flexibility in work environments, performing a variety of frequently changing tasks; ability to plan, negotiate, direct, control and monitor other's activities; and the ability to work alone effectively under stress in situations dangerous to self or others.
- Work involves irregular hours on weekdays, weekends, and holidays. Members in this class are assigned to a 48/144 work schedule (two on, six off) as part of a three to four person engine company, and work a maximum of 1,000 hours per calendar year.
- Salary is \$17 per hour, for a maximum of 1,000 hours per year. Reimbursed out-of-county assignments are compensated separately and do not count toward the 1,000-hour cap.
- This is a limited-term, unbenefited position.

QUALIFICATIONS

KNOWLEDGE OF:

- Principles, practices operations and standard operating procedures of modern emergency medical services, fire prevention, hazardous materials and fire suppression operations.
- Knowledge in the operation and maintenance of fire fighting apparatus and their equipment; be familiar with fireground hydraulics and principles of fire streams and modern fire prevention techniques, and water systems.
- Rules, regulations, and operational procedures of the Willow Oak Fire Protection District.
- Emergency medical skills including basic life support, CPR and defibrillation.
- Fire apparatus, equipment, tools, devices, facilities, and their proper utilization, maintenance requirements and methods.
- Local geography, types of building construction, major target hazards, water supply, fire and building laws and regulations as they relate to the Willow Oak Fire Protection District.
- Occupational hazards and standard safety practices.
- Modern office equipment including a computer and applicable software.

ABILITY TO:

- On a continuous basis, know and understand all aspects of the job and observe safety rules.
- Understand and follow both oral and written instructions quickly and correctly.
- Retain presence of mind in emergencies; analyze fire and emergency situations, adopt effective courses of action, and report to Officer.
- Aquire and maintain skill levels, stay up with new equipment and procedure familiarization, and maintain certifications that are relevant and/or required for assigned responsibilities.
- Communicate clearly and concisely, both orally and in writing.
- Establish and maintain effective working relationships and with those contacted in the course of work;
 courteously respond to community issues, concerns and needs.

EDUCATION

High school diploma or equivalent.

EXPERIENCE

Any firefighting experience is desirable, but not required.

LICENSES/CERTIFICATES

- Possession and continued maintenance of a valid California Class "C" driver's license. Firefighter endorsement is desirable, but not required.
- Emergency Medical Technician I (EMT D) certificate at time of hire.
- Possession of a valid CPR for professional rescuer card at time of hire.
- California State Fire Marshal's Firefighter One Certificate is highly desirable, but not required (the option to acquire FF1 certification through Alternate Delivery via in-house training is available to Seasonal Firefighters).
